Purchase Agreement And Health Guarantee

The paramount importance of this contract is the welfare of the pup/dog !

This agreement is made and signed this _____ day of _____, 200__ by and between Wasserwald Kennel, herein after known as Seller and _____ here in known as Buyer. The Seller, hereby sells a Wasserwald GSD of _____ sex, CKC registration # _____ litter# _____ tattoo # _____ microchip # _____ sired by _____ and out of _____.

The following terms and conditions are agreed to and understood by the Buyer and Seller.

The Buyer agrees to pay a total purchase price of \$ _____

The Buyer shall have the puppy/dog examined by a veterinarian within 72 hours of leaving our home. Should the vet have any concern, the Seller will take the pup/dog back for a full refund of purchase price. The Buyer shall pay for the examination. As of the date that the Buyer receives pup, the Seller shall provide age appropriate vaccinations and deworming. The Seller shall not assume any responsibility for any injury, to the pup/dog after the date of sale.

The Buyer agrees to provide necessary medical attention to this animal and to keep it free of all parasites and fleas; the pup/dog shall be given adequate housing, nutritious food, water, exercise and companionship; and shall not be neglected or mistreated in any manner. The dog shall not be allowed to roam or be chained . Socialization is a must for the puppy and children should be supervised at all times.

Under no circumstances shall the Buyer euthanize this pup/dog except in the instance of traumatic accidental injury or other life-threatening situation where euthanasia is a proper alternative.

The Buyer agrees that the breeders' kennel name, Wasserwald, shall be used as a suffix in the registered name of the dog. Every Wasserwald litter is associated with a letter of the alphabet. This is the "-----" litter. The pup/dog will be named before the transfer of title. Please write in the name with which you wish to register your GSD puppy. All names are subject to approval. The Buyer has chosen the name _____ vom Wasserwald.

The Buyer shall notify the Seller of any change in postal/email address within 30 days of such change.

The Seller guarantees this puppy for 24 months, against major genetic defects. Written proof from a veterinarian of such defect must be presented (and may be verified by Sellers' veterinarian) Should any such defect become evident, the puppy may be exchanged for a puppy from our next litter. **No cash refund or compensation for expenses will be given.**

The Seller does not guarantee that this dog will achieve any specific titles or other achievements during its lifetime.

The Buyer shall notify the Seller of any titles the dog receives within 30 days of the time the dog earns said title.

This puppy/dog is sold on a non-breeding contract registered with the Canadian Kennel Club. It shall be noted that this non-breeding contract can not be lifted without the breeder/seller's signature on the Consent to Cancellation form provided by the CKC.

The pup/dog shall be returned to Wasserwald kennel, at owner's expense, **for rehoming**, should the Buyer require that it leave his care. Ownership rights must be restored to Wasserwald kennel in this situation. We do not want our dogs abandoned, sent to shelters or to non-German Shepherd Dog enthusiasts.

The Buyer shall keep this animal in conformity with local municipal by-laws, and shall assume full responsibility for the actions, of the pup/dog.

The Buyer agrees that he/she is not acting as or in part of, an agent in the purchase of this puppy/dog and that the Buyer shall not sell this animal to any agent, pet store, pet research or guard dog business.

This contract shall be binding on all future owners of said pup/dog.
